The potential donut vendor seems to no longer be interested. Regal would like to move forward with signing up the Skateshop vendor. We would still have room for a food vendor.

Denison moves, supported by Virgil to approve Sunflower Skate Shop. Roll call vote carries unanimously.

There are multiple parties that would like open ice cream shops in Buchanan, one in the Incubator and would require additional hours, a permanent three stall sink, increased

electrical, and is a heavily seasonal business. The board would like to see an application and not decide before one is submitted. Hendrixson would like to see if they could install their own electrical or pay a \$500 minimum electrical stipend.

The Chamber and SCORE will provide classes. Each cohort member will get a free year membership to the Buchanan Area Chamber of Commerce.

For Munchie Mondays, many of the same vendors will return as well as some new ones. Providing electrical is looking positive. It's not metered at the Farmer's Market, but we'll require a small payment if necessary.

There was discussion on potential blade signs for the Incubator. Denison suggests a sign on the corner of the building. They discussed the brick wrap sign and potentially revisiting that idea with a different vendor.

P. Lysy moves, supported by Denison to approve a letter of support from LiveBuchanan. Roll call vote carries unanimously.

MEDC is coming to visit the City, LiveBuchanan, and downtown stakeholders. We will recruit downtown stakeholders to attend.

The group will rotate incubator visiting responsibilities.
